Re: Whatcom Conservation District Supervisors Election, challenge to Commissioners Certification.

Dear Conservation Commissioners,

I respectfully request you not certify Whatcom Conservation District Election held on March 13, 2018 due to a violation and failure to comply with procedures WAC 135-110-610, RCW 89.08.040 and WAC-135-110-150 "...ballots for any conservation district election must be verified as a qualified district elector..."

In response to my voter approved Public Records Request, Mr. Boggs, Executive Director provided a list of district electors/ballots. (See attached) The reported total votes counted in this election is 4397. However, the list of verified district electors/ballots who voted is only 4356. Evidently there are 51 unverified voters that were counted and reported.

In addition, on the list received from the Mr. Boggs the following voters were either inactive voters or not found on the Whatcom County Active Voter list.

This election was decided by 29 votes. With over 51 unverified ballots, and 6 ballots that were counted but should not have been, the outcome of this election is in question. Therefore, the election held on March 13, 2018, due to 51 unverified electors/ballots and 6 disqualified electors should be set aside and should not be certified by the Conservation Commissioners WAC 135-110-120.

A new election should be scheduled in accordance with Conservation District Election and Appointment Procedures. An accurate verification of district electors and ballots must be assured and not left in doubt.


